Chairperson Tracy Dean called in to order the regular meeting of the Madison County Board of Elections and Registration at 5:30 p.m., April 6, 2021, in the Board of Elections and Registration office located at 94 Spring Lake Dr., Danielsville, GA.

Item No. 1. Approval of Minutes

Minutes of the March 2, 2021, have been distributed.

With no additions or corrections to the minutes, the minutes stand.

Item No. 2. Chairperson's Report

The City of Hull cancelled their election due to candidate withdrawal. No problems reported with the City of Comer election. The cost to the City of Hull was \$1589.50 and the cost to the City of Comer was \$3161.30. Invoices have been sent and payment is due within 30 days.

A municipal list of all streets has been sent to each city clerk to review all streets within the city limits. Changes will be made accordingly. Deadline to return to BOER office is May 3, 2021.

A special election will be held in November, 2021, to replace District 3 Commissioner who has resigned effective May 31, 2021. The BOC will set the qualifying fee and the "Call" will be placed in the legal organ in July. Qualifying will be August 16-18, 2021, beginning at 9:00 a.m. and ending at 12:00 noon on the August 18, 2021. Municipal qualifying will also take place at this time at each city.

There will possibly be a countywide TSPLOST in November.

The deadline for all information that will go on the November ballot will be August 20, 2021. This date will meet the deadline set by the SOS for all ballot information.

There has been no new work on the new BOER building. An email was sent to the BOC Chairman and Commissioners stating the deadline to move in order to meet 21-2-265(f). There has been no response to the email. Ms. Dean is still concerned with space since the building will be shared with the coroner.

New IGA's have been sent to the cities.

The Hull precinct will possibly be moved to Joy Baptist Church in Hull. Ms. Dean will visit Joy Baptist to check facility and electrical capacity.

A copy of SB 202 and a summary from the SOS has been distributed to the BOER members as well as a copy entered in to the minutes.
