**Continuation of a 1% Sales and Use  
Tax for Educational Purposes**

(Vote for One)

Shall a special one percent sales and use tax for educational purposes be imposed in Madison County for a period not to exceed twenty (20) calendar quarters and for the purpose of raising not more than \$15,000,000 of net proceeds by said tax, which shall go to the School District for the purpose of (i) paying a portion of principal and interest due on outstanding Madison County School District (Georgia) General Obligation Bonds, Series 2011, the maximum amount of debt service to be paid shall not exceed \$9,500,000; (ii) acquiring a portion of a psycho-educational facility; (iii) acquiring technology improvements, including safety and security improvements, computer technology hardware and software, and infrastructure; (iv) adding to, renovating, repairing, improving, furnishing, and equipping existing school buildings and other buildings and facilities useful and desirable in connection therewith, including, but not limited to, additional classrooms, and transportation facilities; (v) acquiring, constructing and equipping new school buildings and facilities useful and desirable in connection therewith, including, but not limited to, fine arts facilities; (vi) acquiring any necessary or desirable property, both real and personal, the maximum amount of the projects to be paid with sales and use tax proceeds will be \$15,000,000.
